## **II. REVIEW OF PUBLIC SESSION MINUTES**

### **1. Review of minutes from May 25, 2022**

Upon motion of Dr. Semel, seconded by Mr. Alum, the Committee voted to approve the May 25, 2022 minutes as amended. Voting in favor: All.

## **III. EXECUTIVE DIRECTOR'S REPORT**

The Committee members were informed of the passing of long-standing committee member Dr. Delores Johnson as the Executive Director attempted to reach her by phone to join the virtual meeting. The Committee members were shocked and saddened to learn of her death, noting she joined the Committee in 2011 and tirelessly worked on its behalf. Dr. Johnson was an OB-GYN and student of psychoanalysis. The Committee members shared their memories of working with Dr. Johnson over the years, noting her professionalism and the way in which she made the serious work of the Committee a pleasure to perform, especially her input in drafting the regulations which govern the Committee which they called "invaluable." They described her as an honorable and kind person and spoke of how they would miss working with her.

Following this discussion, Ms. Nugent noted there were 41 active Certified Psychoanalysts in the State of New Jersey at present.

## **IV. LEGISLATIVE/REGULATORY**

### **1. Healthcare Transparency Act**

Mr. Manning spoke to introduce the changes this act has on the profession of Certified Psychoanalysts. He noted that this act is implemented by the Director of the Division, rather than the Committee itself. He shared that sometime within the next year the summaries of the regulation changes will be written and shared by the Division.

The Committee members asked about the consequences for a violation of the act, to which Mr. Manning replied that the Committee will have discretion in how any violations of the act are addressed. The Committee

agreed that when and if any complaints regarding a violation of the act come before them they will review these on a case-by-case basis, to determine if the said violation is deemed a major or minor in nature. DAG Palan suggested that when the regulations are officially adopted, information could be added to the FAQ section of the Committee website.

**2. Notice of Discontinuation of TERL Program-announcement of bridge program**

Ms. Nugent noted that the Temporary Emergency Reciprocity Licensure (TERL) program closed to applications on August 1, 2022. Those who already hold TERL licenses will qualify to keep them if they had pending applications for plenary licensure on file as of August 31, 2022. TERL holders will be allowed to continue to practice under these licenses until they achieve full, plenary licensure or until the end of the day on March 31, 2023, whichever comes sooner.
