V. <u>REVIEW OF PROPOSED LEGISLATION:</u>

A. <u>A3754</u>

The Committee reviewed A3754 which required firearms seizure when mental health professional determines patient poses threat of harm to self or others. *The Committee accepted this as informational.*

B. <u>A732</u>

The Committee reviewed A732 which makes it a crime of the third degree to practice psychology, chiropractic, or State-certified psychoanalysis, without a license. *The Committee had concerns with the language of the body of the bill and wanted to clarify that it should be clarified to state "practice as a State-certified psychoanalyst" not just the practice of psychoanalysis. The Committee also inquired why Social Workers and Marriage and Family Therapist including Professional Counselors and Alcohol and Drug Counselors were left out of this bill.*
