III. REVIEW OF MINUTES

1- Upon motion made by Dr. Vicki Semel and seconded by Dr. Jerome Rosenberg, the Committee voted unanimously to approve the minutes for the April 5, 2006 public agenda meeting as presented.

At 12:00 p.m. the Committee moved to executive session to consider the executive session minutes of April 5, 2006.

IV. INFORMATION GATHERING PROCESS

The Committee continued the information gathering process.

Joel Bernstein, Ph.D., The Institute for Psychoanalytic Studies, Inc. Teaneck, NJ

The institute was represented by Dr. Bernstein, the President and Founder of the institute, and Lorna Goldberg, MSW, LCSW, Dean of the Faculty.

The institute, with an emphasis on character analysis, was founded a little over two years ago. Eligibility for enrollment in the program includes at least a master's degree in a mental health or related field. Candidates participate in two control analyses and are required to undergo a minimum of 450 hours of personal psychoanalysis. Three sessions a week of personal analysis for at least a year are required. By the third year, candidates must begin to see at least one patient three times a week. Treatment with a second three time a week patient should be started prior to completion of coursework. From the third year until certification, candidates are required to have a minimum of eight hours of practice a week, with at least four separate patients. Candidates are required to undergo control analysis with at least two successive control analysts. Each control comprises a minimum of fifty sessions. Candidates are expected to remain in control analysis until certification. Candidates are evaluated by the supervisor/control analyst. Once the candidate has completed coursework and met the requirements for personal and control analyses, the candidate is presented to the Training Committee which determines the candidate's proficiency to practice as a psychoanalyst. After receiving a positive determination from the Training Committee, a final case presentation is made. The final case presentation may be in the form of a written paper or an oral presentation.

The course work is as follows:

First year: Psychopathology, Readings in Freud, Transference and Countertransference, Readings in Freud (2). Second year: Early Development, Character Analysis, Dreams, Psychoanalytic Technique: Appreciation of Resistance Third year: Depression, Borderline and Narcisissistic Disorders, Perversions and Immpulse Disorders, Latency Through Adolescence Fourth year: Ego Psychology, Object Relations and Self Psychology, Induced Countertransference, Contemporary Writings: Relational Theory, et al., Advanced Psychopathology
