### **REVIEW OF MINUTES**

### **REVIEW OF REGULATIONS**

A) CPAC regulations - the Committee reviewed a final set of proposed regulations. Mr. Miragliotta informed the Committee that Director Reni Erdos has approved the regulations for publication.

B) Open Public Records Act proposed new rules N.J.A.C. 13:1E-2 Access to Government Records and N.J.A.C. 13:1E-3 Confidentiality of Records. Mr. Brush, Mr. Miragliotta and DAG Sandra Dick reviewed the proposed new rules with the Committee.

C) The Committee reviewed a draft of an application form for certification. Staff will make appropriate revisions to the application.

D) The Committee reviewed the procedures for the case paper examination which will satisfy the examination requirements for certification. The proposed revisions will be made for the next meeting.

## **LEGISLATIVE MATTERS**

S786- Provides State Health Benefits Program coverage for psychotherapy services by marriage and family therapists. The Committee reviewed the bill and on motion made by Dr. Semel, seconded by Dr. Johnson, voted to support the bill with the suggestion that State Certified Psychoanalysts be included in the bill. All voted in favor of the motion.

## **CORRESPONDENCE**

a) Richard E. Cipolla, MA- letter requesting assistance in obtaining a graduate certificate from the Institute for Psychoanalytic Psychotherapies (IPP). The Committee reviewed the matter and determined to request comments from IPP and the National Association for the Advancement of Psychoanalysis (NAAP).
